Talking Points: Spring 2016 ACCESS for ELLs 2.0 and Alternate ACCESS for ELLs

## Overview of Results

- The ACCESS for ELLs 2.0 assessments replaced the Comprehensive English Language Learning Assessment (CELLA) program, which was administered through spring 2015. ACCESS for ELLs 2.0 test forms (ACCESS for ELLs 2.0 and Alternate ACCESS for ELLs) are designed to measure Florida's English Language Learners (ELLs) proficiency in English.
- In the 2015-16 school year, 259,414 ELLs in grades K-12 took the ACCESS for ELLs 2.0 as a paper-based assessment. The Listening, Speaking, Reading and Writing domains have possible proficiency level scores up to 6.0.
- In the 2015-16 school year, 1,202 ELLs in grades 1-12 took the Alternate ACCESS for ELLs as a paperbased assessment. The Listening, Reading and Speaking domains have possible proficiency level scores of up to P2 - Emerging, and the Writing domain has possible proficiency level scores of up to P3 Developing.
