UPDATE: STATE RELEASE OF RESULTS FOR THE SPRING 2010 FLORIDA

COMPREHENSIVE ASSESSMENT TEST (FCAT): GRADE 3

On May 27, 2010, School, District, and State Summary Reports from the Spring 2010 administration of the FCAT to students in Grade 3 were released by the Florida Department of Education. Only student-level data were provided initially on May 25, 2010, with preliminary local summaries calculated by the Office of Assessment, Research, and Data Analysis. The reports released today facilitate statewide comparisons.

Highlights of the District's performance in relation to the state are provided below, and an updated table of longitudinal results is attached. The complete State Report of Districts and District Report of Schools may be accessed at http://oada.dadeschools.net/FCAT/FCAT.asp.

- For the first time, M-DCPS third grade students' performance matched the state, with 78% scoring high on FCAT Mathematics.
- The level of growth shown by M-DCPS third grade students in both Reading and Mathematics exceeded that of the state.
 - o In Mathematics, the percentage of M-DCPS third graders scoring in Levels 3 or above increased by two points from 2009 to 2010, while the state remained the same
 - o In Reading, our third graders posted larger increases in the percentage scoring high (Levels 3 and above), and larger decreases in the percentage scoring in Level 1.
 - The percentage of M-DCPS third graders scoring in Levels 3 or above in Reading increased by three points from 2009 to 2010 while the state increased by only one.
 - M-DCPS reduced the percentage of Grade 3 students scoring in Level 1 in Reading by two points, while the state only posted a decrease of one point.
- M-DCPS surpassed or matched every large district in the state on gains posted in the percentages scoring high in both Reading and Mathematics.
